Program Abstract

This two-day program offers a comprehensive introduction to coding home care and hospice conditions in ICD-10-CM. It includes a review of the basics of ICD-10-CM, with application of the guidelines to more complex scenarios that would typically be encountered in home care and hospice patients. This is a “hands-on” class with practice time allowed to code many of the scenarios. This training is focused on intermediate level coding examples, and will be an excellent preparation for the HCS-D / ICD-10-CM coding certification exam.

The program content will include:

- ICD-10-CM Coding Conventions, general guidelines, terms and definitions
- Chapter specific guidelines and application of the conventions and general guidelines to more detailed scenarios
- Practice scenarios with examples typical to home care patients, discussion of coding scenarios with rationale for code selection and potential coding errors. Day 1 and the morning of Day 2 will cover home care scenarios that can also be applicable to hospice; the last half of Day 2 will be hospice scenarios.
- Identification of the additional information that will be necessary from intake and referral, and from clinical assessment documentation in order to select accurate diagnoses in the ICD-10-CM code set.

Target Audience

This training is appropriate for both coders new to ICD-10 and those who have had an introductory class. A general working knowledge of home health and hospice coding will be very helpful, as the pace of the class is fairly brisk! Those with no prior knowledge of ICD-10-CM Coding may need more time than allowed in class and will need to plan to complete coding some practice scenarios outside of class time.



Materials

Handouts will be made available online prior to the conference. Participants will be required to print and bring a copy of the handouts with them to the conference. This is a “hands-on” class with practice time allowed to code many of the scenarios, so it is recommended each participant bring an ICD-10-CM Coding Manual. (If necessary, two people from the same agency may share a Coding Manual).
